

Processing Periodical Data Advice & Ownership Change Reports in March and April

Impacted Data Advice Customers:

For Data Advice customers that subscribe to both Revised Roll Data Advice AND Periodical Data Advice (e.g., Weekly Data Advice files or Change Reports (pdf)).

Purpose:

This bulletin is to remind Data Advice customers of the importance of downloading and processing files in the correct sequence between the Revised Roll closure date (March 18, 2024) and the 2024 Revised Roll Data Advice release date (March 31, 2024).

Please note that should files be processed out of sequence, the most current data available may be overwritten.

Action Required:

Prior to downloading and processing any Data Advice files, please confirm details found in the corresponding Audit Report. The Audit Report highlights the contents of the file including the date range.

Should any information found in the Audit Report be incorrect, please contact us before proceeding to download any other files. This information can be found in the heading of each report:

For Data Advice Customers who receive <u>both</u> our Revised Roll Data Advice AND <u>Weekly</u> Data Advice products:

March 2024:

- 1. Process the *March 17th* files (20240317_WEEKLY_XXXX) as usual.
- Do NOT process the remaining March 24th and March 31st files
 (20240324_WEEKLY_XXXX, 20240331_WEEKLY_XXXX) until the 2024 Revised Roll Data
 Advice files have been processed.

April 2024:

- 1. Process the 2024 Revised Roll Data Advice File (**20240401_REVD_XXXX**). This is the first file for 2024.
- 2. Go back and process the remaining *March 24th and March 31st* Data Advice files (20240324_WEEKLY_XXXX, 20240331_WEEKLY_XXXX).
- 3. Starting with the *April 7*th file (20240407_WEEKLY_XXXX), the files can be processed as normal.
